Under Article 7 of the Law on Public Procurement ("Official Gazette of the Republic of Serbia No. 68/2015), the Directive on Procurement in the Diplomatic and Consular Missions of the Republic of Serbia No. 716/GS of 20 May 2013 and the Instruction on the Conduct of Procurement in the Diplomatic and Consular Missions of the Republic of Serbia No. 716-2/gs of 3 July 2013, the Embassy of the Republic of Serbia in Brussels is hereby making the

DECISION

on awarding the contract for the procurement of goods Tempest computers for the needs of the Diplomatic and Consular Missions of the Republic of Serbia abroad

THE CONTRACT IS AWARDED TO THE BIDDER E-Smart Systems Ltd. Belgrade, 70a Kneza Viseslava St., Belgrade, Serbia, that submitted the bid No. 548/16 of 8 September 2016, registered at the Embassy under No. 273-10 on 8 September 2016.

Rationale

On 17 August 2016, the Procuring Party made the Decision No. 273-1/2016, of 17 August 2016, on launching the contract awarding procedure for the procurement of goods-Tempest computers, for the needs of the Diplomatic and Consular Missions of the Republic of Serbia abroad.

The call for the submission of bids and the Tendering Documents were published on the webpage of the Embassy of the Republic of Serbia in Brussels, on 18 August 2016.

Upon the completion of the bids opening procedure and the drawing up of the Minutes on the opening of bids No. 273-13/2016 of 9 September 2016, the Committee for the procurement in question proceeded to the professional assessment of bids and drafted the Report on the professional assessment of bids No. 273-14/2016 of 19 September 2016.

The Committee has noted the following in the Report on the professional assessment of bids:

1. The subject and the assessed value of the procurement:

The subject of the contract awarding procedure is the procurement of goods-Tempest computers, for the needs of the Diplomatic and Consular Missions of the Republic of Serbia abroad.

The assessed value of the procurement is RSD 11,000,000.00 without VAT, i.e. EUR 89,273.7579, without VAT.

2. Data from the procurement plan

The 2016 procurement plan of the Ministry of Foreign Affairs for the Diplomatic and Consular Missions envisages the procurement of the above-mentioned equipment. The financial resources for the procurement in question have been provided under the Law on the Budget of the Republic of Serbia for 2016 ("Official Gazette of the Republic of Serbia" No. 103/15), Section 17.1-Diplomatic and Consular Missions, Function 113, economic classification 512- machinery and equipment, source 01 (budget).

3. Deviation from the procurement plan

No deviations from the procurement plan have been made.

4. Basic data on Bidders and bids:

Three Bidders took part in the contract awarding procedure in question. The bids opening procedure was conducted on 9 September 2016, beginning at 13:30, and it took place simultaneously at the offices of the Ministry of Foreign Affairs, 24-26 Kneza Milosa St. in Belgrade and at the offices of the Embassy of the Republic of Serbia in Brussels, 1000 Brussels, 53 Boulevard du Regent, Belgium. Conference communication was maintained via the VOIP network, set up at the level of the Diplomatic and Consular Missions of the Republic of Serbia abroad and the Ministry of Foreign Affairs.
